### DESCRIPTION

Epocast<sup>®</sup> 1610-A2 epoxy syntactic is a very low density, flame retardant, one component system with a long storage life at room temperature. It can be co-cured with composites in 60 minutes at 260°F (127°C). Epocast<sup>®</sup> 1610-A2 epoxy syntactic is well suited for replacing pre-cured foam or wood blocks in honeycomb panels. After curing under vacuum, the lightweight epoxy produces high-strength areas for insert potting with no mark off. Epocast<sup>®</sup> 1610-A2 epoxy syntactic cures to an off-white color.

### **CURE SCHEDULE**

Raise temperature 5-7°F (3-4°C) per minute from room temperature to 260°F (127°C), then cure for one hour at 260°F (127°C). Cool under vacuum to 150°F (66°C) before removing part.

Epocast<sup>®</sup> 1610-A2 should be stored in a dry place, in the sealed original container, at temperatures between +2°C and +8°C (+35.6°F and +46.4°F). The product should not be exposed to direct sunlight. Under these storage conditions, and when supplied under Huntsman standard certification, this product has a shelf life of 6 months from date of shipment (expiration date may differ based on customer specification).

Material temperatures should be above 18°C (65°F) when mixing. After use, tightly reseal containers.
